I, the undersigned player acknowledge, agree and understand that:

1. All activities that are part of the Oakdale Adult Softball Program are undertaken by me at my own risk and that the City of Oakdale shall not be liable for any claim, demands, injuries, damages, actions or causes of action whatsoever to myself or to my property including, but not limited to, the passive or active negligence of the City of Oakdale, its agents or employees, and I further hold the City of Oakdale harmless from all such claims, demands, injuries, damages, actions or cause of action whatsoever arising out of my participation in the softball program.
2. Playing softball is hazardous and many aspects of softball are dangerous and may result in injury to me or other players; and;

I agree that in consideration for the City's permission to play on the City of Oakdale property:

I assume all risk of injury incurred or suffered while on and/or upon the premises of the City of Oakdale property.

DATA PRIVACY ADVISORY

Under the Minnesota Government Data Practices Act, you are entitled to know the following about the information, which the City of Oakdale collects from you:

1. The following information about individuals who are enrolled in a City of Oakdale recreational or social program is classified as private data: name, address, telephone number; other data that identifies an individual; data that describes the individual's health or medical condition, family relationship or living arrangements and opinions about the individual's emotional makeup or behavior.
2. The information which you provide to the City of Oakdale on the roster form is used to process your registration request, to determine City of Oakdale staff, facilities and equipment needs and to assist coaches/managers in notifying participants of scheduling changes.
3. Participation in any recreational program is voluntary, and you are not legally required to provide the information requested on the roster form. However, if you fail to provide the information, you will not be allowed to participate in the program.
4. The information you provide will be made available to the City of Oakdale staff persons in the Oakdale Adult Softball Association, program participants, the City of Oakdale insurer and attorney and to the coach/manager or supervisor, who may be a City of Oakdale employee or a volunteer.
